notify the federal government of a death canada ca Jan 08 2021 jul 07 2022 you may have to inform several federal programs departments or agencies depending on the deceased person s situation and where they lived it is important to report the death of a beneficiary to the federal government quickly to avoid benefit overpayments do this within the first 2 weeks following the death sections document you need
